

Morning Christine and Dave

As discussed below are my notes for the teleconference (thought this might help you with the minutes):

FNQ Regional Director Deb Dunstone and QPS Acting Chief Superintendent Brett Schafferius – have been in regular communication since Sunday. DET has appreciated this support from QPS. The Officer in Charge Peter James has also been in contact with the Head of Campus in Aurukun Kon Kalos. Whilst the situation remains tense in community there is ongoing communication between QPS and DET.

Staff are very aware via their local community contacts and Elders that work within the school how tense the situation remains. They appreciate the additional Police presence but understandably feel how tense and for some, how frightening this situation has been.

An issue for staff yesterday was the perception that all other NGO agencies had sent staff home or out of community. With the Council and shop also closed they understandably felt vulnerable and that the messages were mixed around community. Significant communication occurred to support staff during this time. Staff were offered the opportunity to travel to Weipa if they felt they needed to leave community. This was supported by DET. Only 8 staff to date have made their way to Weipa. The school did go into lockdown yesterday around the time of the incident at the shop. Staff thought they heard gun shots at this time. Elders were also advising staff that they thought things were going to get worse in town in the lead up to the Funeral on Thursday.

#### DET Update 10am Tuesday:

- Mr Leigh Schelks is travelling to Aurukun this morning to support the Head of Campus and Staff. Leigh will be the Executive Principal of CYA in 2016. Leigh will report directly to the RD. Additional support will be provided if required once Leigh is able to assess the situation.
- 6 Teachers and 2 Teacher Aides are currently in Weipa. The HR Director is liaising with these staff and we
  will individualise their capacity to return to community. EA services have also been offered to these
  staff. We expect some work cover claims.
- 16 staff have remained in Aurukun. We will continue to support Staff who ask to travel out to Weipa.
- School is open today attendance is very low 35 students. 13 Staff are providing support to students.
- We are liaising with the Psychologist that is working with CYA to provide some additional face to face support for teachers requiring this in Aurukun.
- The RD has briefed the QTU President and Local Organiser given staff, their Parents and Partners were phoning requesting support and outlining their concerns for their welfare (this settled after the weapon was located). QTU President very supportive of current plan by DET.
- RD is in constant communication with CYA and will provide ongoing support as required.

All is well managed at this point – there are no major concerns – just lots of support happening.



# Situational report on Aurukun unrest as at 23 November 2015

#### **Background**

The unrest is reported to have commenced on the evening of Saturday, 21 November 2015. There are reports that up to 12 people were involved.

While the reasons for the unrest are yet to be fully established, it is understood that it was precipitated by alcohol-fuelled violence following from the unsuspicious death of a young Aurukun woman recently.

Shots were fired and rocks thrown at a police car and another vehicle was torched. Around 9:20pm a man was hit by a car and taken to the Aurukun medical clinic where he died.

# Queensland service responses

<u>Queensland Police Services (police)</u> – police state that the community is currently calm and no arrests have been made at this stage. However, a community member is assisting the police and is likely to be charged. The firearm used on Saturday evening is now in police possession.

In addition to the ten police based in Aurukun, a further 21 police have been flown to Aurukun, including an experienced officer. This officer has held discussions with the Chief Executive Officer and Mayor of Aurukun Shire Council and with one of the family groups in dispute.

Following the investigation and restoration of calm, police numbers are expected to reduce to usual numbers. Mediation with conflicting families will commence when appropriate.

In the meantime, police will visit each of the services operating in Aurukun to discuss safety and offer patrols if needed.

<u>Cape York Aboriginal Australian Academy (CYAAA) school</u> - contrary to some reports, teachers have not been advised by the Queensland Government to vacate Aurukun. The school was open on 23 November 2015 with 22 students in attendance.

Some teaching staff were distressed and travelled to Weipa and all CYAAA teaching staff have left Aurukun.

The school's new executive principal is travelling to Weipa on 24 November 2015. It is hoped that teachers will return to Aurukun with her.

<u>Queensland Health</u> – the Aurukun health clinic is open and additional mental health staff are being sent to Aurukun to assist families affected by the unrest.

<u>Restorative Justice Program</u> – indications are that the program has referred five people to Weipa Community Care (Women's Shelter) to support some local people (women, children and elderly).

Queensland's Department of Justice and Attorney-General is liaising with the program staff to ascertain how they might be able to support people who may need to leave the community in the short term.

<u>Aurukun retail store</u> – DPC understand that the store has been in 'lock-down' – it is unclear whether the store has re-opened.

<u>Non-government services</u> – non-government service staff including the Royal Flying Doctors Services and Apunipima Community based health centre are not operating in Aurukun today.

#### **Next Steps**

The Queensland Government will continue to closely monitor developments in Aurukun including the anticipated funeral of the young Aurukun woman later this week which may be a further flash point.

Morning Christine and Dave

As discussed below are my notes for the teleconference (thought this might help you with the minutes):

FNQ Regional Director Deb Dunstone and QPS Acting Chief Superintendent Brett Schafferius – have been in regular communication since Sunday. DET has appreciated this support from QPS. The Officer in Charge Peter James has also been in contact with the Head of Campus in Aurukun Kon Kalos. Whilst the situation remains tense in community there is ongoing communication between QPS and DET.

Staff are very aware via their local community contacts and Elders that work within the school how tense the situation remains. They appreciate the additional Police presence but understandably feel how tense and for some, how frightening this situation has been.

An issue for staff yesterday was the perception that all other NGO agencies had sent staff home or out of community. With the Council and shop also closed they understandably felt vulnerable and that the messages were mixed around community. Significant communication occurred to support staff during this time. Staff were offered the opportunity to travel to Weipa if they felt they needed to leave community. This was supported by DET. Only 8 staff to date have made their way to Weipa. The school did go into lockdown yesterday around the time of the incident at the shop. Staff thought they heard gun shots at this time. Elders were also advising staff that they thought things were going to get worse in town in the lead up to the Funeral on Thursday.

#### DET Update 10am Tuesday:

- Mr Leigh Schelks is travelling to Aurukun this morning to support the Head of Campus and Staff. Leigh will be the Executive Principal of CYA in 2016. Leigh will report directly to the RD. Additional support will be provided if required once Leigh is able to assess the situation.
- 6 Teachers and 2 Teacher Aides are currently in Weipa. The HR Director is liaising with these staff and we will individualise their capacity to return to community. EA services have also been offered to these staff. We expect some work cover claims.
- 16 staff have remained in Aurukun. We will continue to support Staff who ask to travel out to Weipa.
- School is open today attendance is very low 35 students. 13 Staff are providing support to students.
- We are liaising with the Psychologist that is working with CYA to provide some additional face to face support for teachers requiring this in Aurukun.
- The RD has briefed the QTU President and Local Organiser given staff, their Parents and Partners were phoning requesting support and outlining their concerns for their welfare (this settled after the weapon was located). QTU President very supportive of current plan by DET.
- RD is in constant communication with CYA and will provide ongoing support as required.

All is well managed at this point – there are no major concerns – just lots of support happening.
