

### Welcome

Connect is a three-year (Special) Religious Education curriculum designed for use in Australian and New Zealand schools. It is **Bible-based** and offers 20 lessons each semester at Infants, Lower Primary and Upper Primary levels.

The curriculum has as its foundation the belief that it is important to allow the Bible's own theological framework to determine what is taught and how it is taught. It is therefore **content-structured**, teaching the major events, concepts and doctrines of the Bible.

The intention of Connect is to introduce students to God and his saving purposes for the world through Jesus Christ, his Son.

This curriculum is also **student-related**. It is designed to engage students' minds and emotions as well as develop the skills needed for students to explore the nature and content of the Christian faith.

### Educational approach

Like all other CEP children's ministry resources, Connect draws on recent research on the way students think and learn. Importance is placed on:

- teaching concepts in a way that is appropriate for the age and developmental stage of the students;
- recognising that intuitive or tacit knowing means that students generally have more of a grasp of a concept than they can express in words;
- acknowledging that knowing requires more than intellectual experience because it involves the emotions as well;
- relating all that is taught to their experience; and
- providing discussion and activities that encourage students to reprocess information and make it their own.

Connect uses a range of teaching and learning strategies to engage the intellectual strengths and preferred learning styles of all students. Teachers are encouraged to try a variety of these in order to discern which approaches best suit the needs of their classes.

The overriding aim of this curriculum is to present the heart of God's message of salvation in a clear and attractive manner. For maximum effect this will require thinking beyond the immediate lesson to ways of linking interested students to church-run children's and youth activities, so they can experience Christian community and learn more about the Christian faith.

### Curriculum structure

Connect is a three-year curriculum presented at three separate levels—Infants (for students aged 5 to 7), Lower Primary (ages 7 to 9) and Upper Primary (ages 10 to 12)

Accordingly students will only meet the particular Bible passage, upon which a lesson is built, twice during these years. The lesson content and learning outcomes are different at each level, achieving both reinforcement and learning at greater depth as the student progresses through school.

Additional CEP curricula are available: Beginning with God is for the first year of school and Big questions is for students in the last year of primary school and making the transition into high school. A series of CEP high school resources is also available. See the current CEP catalogue for details or contact CEP.

### Content

Connect B1 takes up the Bible's story of salvation, linking Jesus' life, death and resurrection with God's promises in the Old Testament to give students a big-picture view of God's plan to redeem a fallen world. The lessons begin with Jesus in the book of Luke; he is humanity's Saviour and Lord and the whole Bible points to him. An examination of Jesus' life (including his words and actions) shows that Jesus is God's powerful Son who saves us from our sins and fulfils God's promises (2 Corinthians 1:20). The second half of the semester introduces students to people in the Old Testament who received promises from God, starting with Abraham and ending with Joseph and his family in Egypt. Abraham is an essential figure in the B cycle because the investigation of God's promises to him enables students to become familiar with biblical theology concepts, whereby they can come to an understanding of how the whole Bible fits together. There is also a special lesson on coping with change, and another introducing students to a contemporary Australian Christian

Connect B1 leads into Connect B2, which continues following Old Testament events beginning with God's people in slavery in Egypt. In the second half of the semester, students learn about how God's promises to Abraham are ultimately fulfilled in Jesus. The specific promises of God on view here begin with Abraham and culminate in Jesus (secured in his first coming and brought to completion at his return) and are for the inclusion of the whole world, and therefore, each student.

### Special lessons

As well as the Christmas and Easter lessons in the curriculum, a special assembly idea for these major Christian celebrations is provided for those who may be asked to conduct a whole school or large group activity.

Each semester also contains a lesson dealing with a major issue that children may face. This semester has a lesson on changes, and provides a biblical basis for how students can cope with different types of changes in their lives

### **Curriculum stance**

### Theological

This curriculum, designed for use in (Special) Religious Education classes in schools, is written from a biblical perspective that accords with the historic creeds of the Church.

The underlying theological assumption is that we humans are made in the image of God. Consequently, we first need to understand God as he reveals himself in the Bible, pre-eminently in the person of Jesus Christ, before we can understand ourselves. This curriculum intentionally differs from those that adopt a human frame of reference or that focus on themes derived from other school curricula.

The curriculum does have a grounding in the biblical theology from creation to our present existence in the last days. The students are encouraged to see the whole Bible as God's plan of salvation. In *Connect* the students are introduced to the timeline of the Bible so they can see for themselves where various events they read about in their Bible took place in relation to the overall outworking of God's plan.

A more detailed understanding of this approach may be obtained by consulting:




